COMMENTS:

This Sundry Notice (Form 4) is to inform the COGCC that SandRidge will be land incorporating the stockpiled cuttings as a beneficial amendment on the well pad location per the approved E&P Waste Management Plan, submitted and approved on June 22, 2016 (Document No. 401062567). On August 28, 2016, one soil sample was collected from the cutting stockpile to demonstrate compliance with COGCC Table 910-1 concentration levels as outlined in the E&P Waste Management Plan, prior to incorporation. All analytical results were compiant with COGCC Table 910-1 concentration levels, except for pH, which had a concentration of 9.31. Once incorporated into the existing pad, SandRidge will collect one composite soil sample of the incorporated material for compliance with COGCC Table 910-1 concentration levels. Successful remediation of pH will be demonstrated by either (a) pH concentration results within the acceptable COGCC Table 910-1 concentration levels range after incorporation, or (b) successfull establishment of vegetation when the pad is reclaimed.
