We will add two feet of clean soil to the bottom of the pit (see sourcing below). We will use the backhoe to blend the clean soil in with the bottom of the pit. Then the pit will be backfilled with remaining clean soil. Clean soil source: If backfill of pit exists, this material will be utilized to backfill pit. Native fill material may be collected from the recontouring of cut and fill slopes. Clean fill material will be brought onsite, if needed.

	Operator has received COGCC approval to discontinue testing for Arsenic for produced water pit closures. Due to elevated SAR on the bottom of pit operator must ensure that remaining pit contents are covered with a minimum of 3 feet of backfill and soil. The soil horizons must be replaced in their original relative position, and reclaimed in accordance with 1000 Series Rules.
