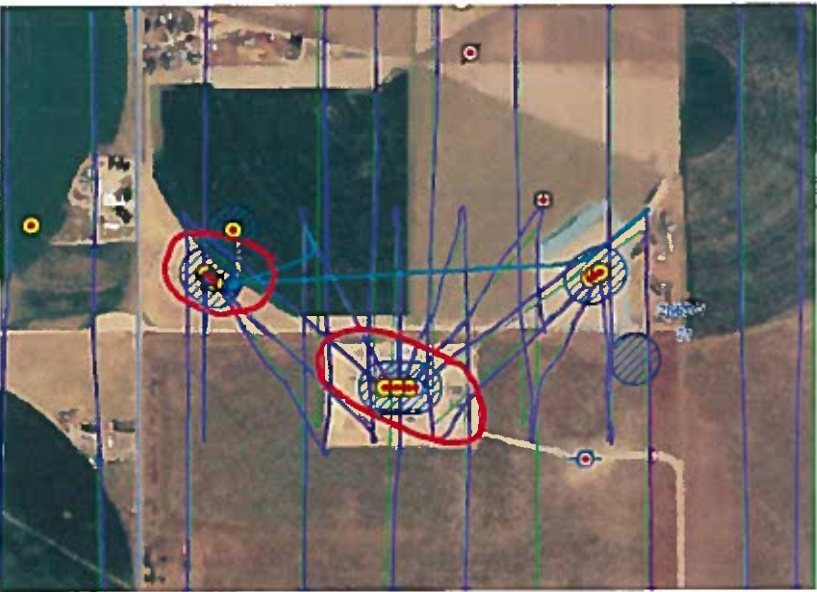
Hi, Matt,

We had an informal discussion about this issue last week in Diana's office.  
KMG needs to plug two horizontal wellbores on their Adamson location that have fish stuck in the hole; they are proposing to do this with two intercept wells to be drilled from a nearby Meguire location. The intercept wells will allow the plugging in the horizontal wellbores to be done downhole.  
The amended 2A and APDs were submitted last week and KMG is seeking approval no later than tomorrow to address possibly unstable wellbore situations. Currently, both wells are flowing and production is going to sales.
