Pioneer is requesting continued temporarily abandon status on the Dempsey 31-22 well as it is not feasible to rework the well at this time due to current market conditions. A Form 4 for continued temporarily abandon status was submitted to the COGCC on 8/23/2016. A Mechanical Integrity Test dated 9/16/2014 has also been previously submitted. The Dempsey 31-22 well is closed to the atmosphere via a wellhead secured and shut-in by a valve as well as a bridge plug set at 2875'.
