Comment: [Inspection doc. #682502088](#) required operator to perform reclamation on the access road and location, and to remove pipe riser equipment. [Inspection doc. #675103838](#) in response to FIRR doc. #401296905 documented that battery/well have had reclamation work conducted, but pipe riser and road had not been reclaimed. Pipe riser equipment has been removed, however access road has not been reclaimed in accordance to COGC 1000 series reclamation requirements. Original CA and CA date remains applicable.

Corrective Action:	<b>Perform</b> reclamation: remove equipment (cattle guard/gate) from access road, remove gravel from access road. Perform compaction alleviation, recontour, regrade access road. Manage weeds and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 6/30/2017	Date	<b>06/30/2017</b>
