**Environmental****Spill/Remediation:**

Comment: Excavation of petroleum hydrocarbon impacted soil along the north wall of the produced water pit has extended below the water table. Petroleum hydrocarbons have accumulated on the surface of the water

Corrective Action: Remove the petroleum hydrocarbon impacted water from the excavation and properly dispose. Continue to monitor the open excavation for petroleum hydrocarbon accumulation on a daily basis and remove/dispose as needed. Provide daily photographs of the open excavation until it has been backfilled to allow access for additional impacted soil removal.
