Pioneer is reporting completion of final reclamation for the Cora 21-19 Offsite Pit located in Las Animas, County Colorado. Pioneer has conducted a reclamation consultation with the surface owner who has requested that the pit shall remain in place and not be re contoured to natural state; the surface owner has stated that the pit in its current state is beneficial to his ranching operation in collecting storm water runoff for the purpose of watering livestock. The surface owner has requested that the pit remain in place as is, that the surrounding area be seeded with the surface owners specified seed mixture; and that storm water runoff be ditched into the pit.
