Comment: Inspection #682502418 documented that crop growth at the battery location is not uniform, and stunted when compared to that of the reference area, noting that this is likely due to compaction concerns. Inspection required operator to perform additional reclamation in accordance to COGCC 1000 series reclamation requirements at the former battery location. Unable to find evidence that additional reclamation activities have been conducted per the corrective action. Original corrective action and corrective action date remains applicable.

Corrective Action:	Perform additional reclamation on in accordance to COGCC 1000 series reclamation requirements and standards. To allow time for Noble to collaborate with the surface owner and determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production, and to allow time for Noble to identify the issues hindering crop growth, all additional reclamation activities shall be completed no later than September 15th, 2017	Date	09/15/2017
