Comment: Stormwater is directed down and across the access road toward the highway which is depositing sediment and creating vehicle tracking of sediment onto the highway. A culvert may be needed to direct stormwater flow to the highway drainage ditch. Additional stormwater erosion is occurring further along the road which has created a 3.5 ft. gully along the road. A culvert appears to be full of sediment and stormwater is not being properly directed toward the culvert. The cut slope at the location is not stabilized and is depositing sediment onto the location. See Attached Photos
