General Comment:

This is a follow-up final reclamation inspection to inspection #682500705, #682501380, #682501959 and #675103907. This is also an inspection in response to complaint #200444116 submitted on 10/08/2017 by the Surface Owner. In the document, the complainant indicated that no work has been done since May regarding reclamation. At approximately 09:50 on 10/10/2017, Reclamation Specialist Trujillo contacted the complainant via the phone. Though the complainant had re-expressed concerns regarding the reclamation of the location and access road on his property, he stated that after submitting the complaint on the 8th, he had visited his property on the 9th and that it appears work had began as the cattle guard had been removed. Previous inspections had required HRM to perform reclamation per COGCC 1000 series rules. See the reclamation portion of this inspection for additional details. Any corrective actions from previous inspections that have not been addressed are still applicable.

Perform reclamation in accordance to COGCC 1000 series reclamation rules. Remove gravel and perform compaction alleviation, re-grade/re-contour access road to that of the adjacent reference areas. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland or a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 11/15/2016.

RECLAMATION COMMENT Inspection doc. #675103907, as well as other prior reclamation inspections, required operator to perform reclamation in accordance to COGCC 1000 series reclamation rules including, but not limited to, the removal of gravel and cattle guard equipment, the performing of compaction alleviation, and re-contouring/re-grading the access road to that of the adjacent reference areas. Cattle guard and gravel appear to have been removed. A contractor performing the work for the operator was on site at time of inspection and was in the process of bringing additional topsoil for the access road. After conversations with the contractor, it was indicated that compaction alleviation (cross ripping) to the required depth of 18 inches, and reseeding had not yet been conducted, and that though the reseeding of the location is planned, there was no schedule to perform the compaction alleviation. Original corrective action and corrective action date will remain applicable until all reclamation work and activities have been conducted in accordance to COGCC 1000 series reclamation rules and requirements.	trujilloam	10/10/2017
