Per COGCC Rule 326.f.(1), we understand a well that fails an MIT shall be repaired or PA within 6 months of the failed test. Marathon Oil is requesting a 12 month extension from 3/27/2018, to 3/27/2019 to have the ability to diagnose and remediate the problems associated with the failed MIT.
