COGCC Representative: Commission has received the notice. It is not an acknowledgement that the corrective action has been passed. A field inspection will be conducted to evaluate compliance with COGCC standards.

Corrective Action: Reclaim access road and location in accordance to COGCC 1000 series reclamation requirements and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. The prime time frame for a spring seeding has passed, to take advantage of a fall seeding, revegetation activities shall be complete no later than 11/15/2017.

Basis for Review: Corrective action dates are not attainable

Operator Comment: This location is an active remediation site, project number 3281. Final reclamation cannot take place until the remediation project has been completed.

COGCC Decision: **Not Approved**

COGCC Representative: COGCC records indicate that the remediation project number cited by the operator (#3281) is not associated with the CJ Schmidt well. Records shows project #3281 is associated with the HSR-Vasser well, API # 123-15484. Operator will need to contact environmental to update records so that the remediation project is associated with the correct well, API and location.

COGCC Supervisor: COGCC Decision "Not Approved". After interaction with the environmental group, it was determined that the access road can remain until closure of the remediation project. However, reclamation will be required throughout the remainder of the location. Areas around the piezometers (monitoring wells) will need revegetating for site stabilization. Upon closure of the remediation project, reclamation of the access road will commence immediately.

Comment: Weeds have been mowed throughout location and will continue to be monitored and managed until final reclamation can be completed.
