Comment: This location does not meet reclamation requirements. Cheatgrass (Bromus tectorum) was the dominant vegetative cover, including, but not limited to, Crested wheatgrass (Agropyron cristatum) and Western wheatgrass (Pascopyrum smithii) which is not reflective of reference area levels. Reference area vegetative cover consisted mainly of Smooth brome (Bromus inermis), Switchgrass (Panicum virgatum), Sideoats grama (Bouteloua curtipendula), and Crested wheatgrass. Refer to the attached inspection photos for more detail.

Corrective Action:	Perform reclamation in accordance to COGCC 1004 reclamation rules and requirements. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. The Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards. Final reclamation activities shall be complete no later than November 10, 2017.	Date	11/10/2017
