Inspection #675103753 also documented that location will need to be re-contoured and returned to agricultural activities. This corrective action remains applicable.

Perform reclamation in accordance to COGCC 1000 series reclamation standards including, but not limited to, compaction alleviation, re-contouring, regrading and revegetation. Collaborate with the surface owner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production. All reclamation activities shall be completed no later than 10/15/2017.
