Catamount Energy Partners LLC, is proposing to drill the above referenced well on a tract of land owned by the Joe L. Herrera, Sue C. Herrera and Annette C. Gallegos. In order to minimize surface damages, Catamount Energy Partners LLC has staked the proposed well approximately one hundred and nine feet (109') North of your property. The Colorado Oil and Gas Conservation Commission (COGCC) under Rule 603.(2) requires that a well be located no closer than 150 feet to an adjacent property boundary. If a well is not 150 feet from the boundary then a waiver must be obtained from the adjacent landowner.
