I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

1) In the Cultural Setback Distance section you have indicated the distance to the nearest Property Line is 873 feet from the nearest proposed well and 642 from the nearest proposed production facility. During my review, it appears that Weld County Road 128 to the south is the nearest property line and is closer to a proposed well and production facility than the distances Fifth Creek has listed. While the Wahlert's do own the property on both sides of WCR 128, the county road does act as property boundary as it separates two parcels of land. Please provide me with revised distances to this nearest Property Line.

2) During my review there do not appears to be any surface water features within 1,000 feet of this proposed Oil & Gas Location. When this is the case, an operator is not required to include a Hydrology Map but must provide an operator comment that indicates this. Therefore, I would like to add an operator comment to this effect to the Form 2A.
