Inspection #682500888 documented that equipment remains, and that corrective action has not been addressed.</p> <p>Equipment still remains on the location, no work appears to have been conducted; operator has failed to perform the required corrective actions. Original corrective action and corrective action date remains applicable.</p>	
Corrective Action:	<p>This is the third inspection requiring work to be conducted. Remove all equipment, pipe risers, and metal box. Establish vegetation with total perennial non-invasive plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland or a seed mixture requested by the landowner. Continue to monitor and manage this site until Final Reclamation has Passed.
