Groundwater was encountered during excavation activities at approximately 5 feet below ground surface (bgs). PDC will conduct quarterly groundwater sampling at the nine monitoring wells to assess dissolved BTEX impacts in groundwater using USEPA Method 8260. Groundwater sampling will continue until four consecutive quarters of groundwater monitoring data indicate that BTEX concentrations are in compliance with the COGCC Table 910-1 groundwater standards.
