Comment: **Previous inspection documented that the "valve body/bodies buried in barrel and well not capped off or buried" and had required its removal. Equipment remains on location and has not been removed. See attached photo document. It appears fluids may still be discharging from the riser/valve.**

Corrective Action:

Date **03/31/2018**

Remove pipe equipment, perform reclamation and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 3/31/2018.
