Operator response of "Corrective Action Complete" indicates that the corrective actions requiring reclamation have been addressed. Operator has not provided documentation showing work has been conducted and comments within this resolution suggest that the corrective action requiring reclamation has not been completed.

COGCC acknowledges Bonanza Creek's intent to pursue a variance. Operator has been aware of the requirements for a 502.b variance to not perform reclamation since July 10th, 2017. As of November 7th, 2017 no 502.b variance has been submitted by the operator, or approved by the COGCC.

COGCC can not assume operator will submit a variance request and until a 502.b variance has been submitted/approved, the location will remain subject to COGCC reclamation rules and requirements. This is being referred to enforcement.
