Proposed Procedure:

1. Notify COGCC, BLM 48 hrs prior to start of activity via electronic Form 42
2. Move in rig up Cameron 4-1/16" 10K wellhead
3. PSI test casing to 9,500 psi for 30 mins (< 2% leak off Required to pass)
4. Rig up Reliance Wireline perforate Lower Cameo
5. Move in rig up Halliburton frac Lower Cameo
6. Continue stage frac thru MV 5 (Top Perf < 6,435')
7. Shut down frac operations
8. Begin flowback operations
9. Notify COGCC, BLM 48 hrs prior to start of activity via electronic Form 42
10. Rig up Reliance Wireline Set Kill Plug at 6,140'
11. Remove Cameron 4-1/16" 10K wellhead
12. Nipple up BOP's and psi test to 4000 psi
13. Shoot three perforations 120 degree phasing at 6,130'
14. Pick up CICR and set at 6,080'
15. Pump 613 sks 12.8 PPG NEO lead and 75 sks 15.8 ppg tail Cement into hole at 6,130'
16. Rig up Reliance Wireline run CBL to evaluate cement top
17. Drillout CICR
18. Pressure test well to 8,000 psi
19. Move in rig up Cameron 4-1/16" 10K wellhead
20. Rig up Reliance Wireline perforate MV6
21. Move in rig up Halliburton frac MV6, MV7
22. Shut down frac operations
23. Begin drillout and flowback operations
