**General Comment:**

This is an inspection in regards to produced water discharge from the Marick State Tank Battery. On 11/1/2017, inspector observed produced water was being discharged from the over-flow siphon on the southeastern side of the tank, and from the manifold on the north end of the produced water tank into the containment berm. At 12:08 inspector called the emergency line on the sign and notified Mr. Tibson of the spill, that it needed to be stopped immediately, and to provide a 48 hour notice to perform clean-up. At approximately 13:30 inspector was contacted by Mr. Peterson with Diamond Operating. Inspector provided Mr. Peterson details of the spill and that a form 19 will need to be submitted. At approximately 14:00 inspector met with pumper on the site. Pumper was able to shut-in the wells and stop any additional discharge from occurring. The pumper informed inspector that they intended to remove the fluids and that a vacu-pump truck was on it's way.
