Noble respectfully requests to add one (1) Buried Produced Water Vault to the Centennial State G35 Tank (Location ID449985). With this addition, Noble's total Buried Produced Water Vault count will now be three (3). Due to the addition of this equipment, the permitted area of disturbance will not change from 8.20 acres. Also, the placement of this piece of equipment will not affect the cultural distance measurements permitted on location.

1	Construction	<p>Construction- Water Vault BMP will be applied to the requested Buried Produced Water Vault:</p> <ol style="list-style-type: none"><li>1. A contiguous spray liner will be installed and will underlay the entire tank battery. The location of a partially buried cement water vault will be excavated prior to liner install.</li><li>2. A 60 bbl cement water vault will be utilized to collect excess produced water from oil tanks. Produced water in the vault will be removed as needed and disposed of in an approved UIC disposal well. The cement water vault is one piece with no seams designed to minimize potential for leaks. All piping associated with the use of the water vault will be aboveground and visually inspected on a regular basis.</li><li>3. The partially buried cement water vault will be installed above the spray in liner.</li><li>4. A sized steel secondary containment ring will be installed surrounding the entire tank battery. Sand and gravel bedding will be installed to protect the liner prior to placing equipment in the containment area.</li></ol>
