560 acres

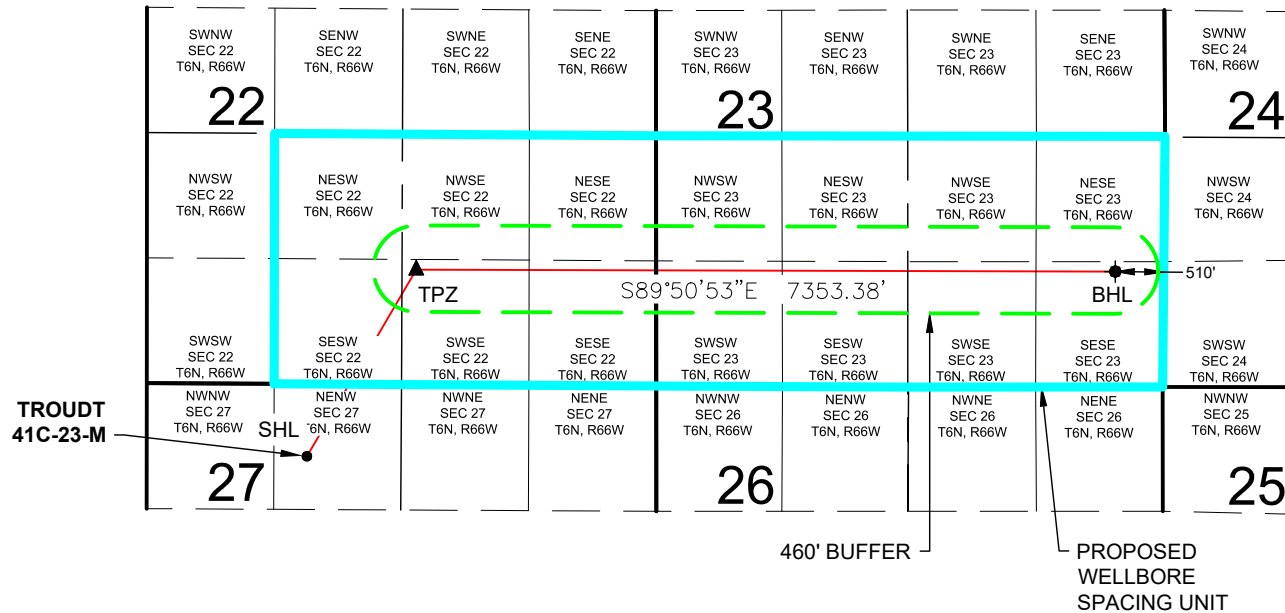

The required thirty (30) day notice period has elapsed absent the receipt by SRC Energy of any objection to their proposal by the owner(s) within the proposed spacing unit for the subject well. # TROUDT 41C-23-M WELLBORE SPACING UNIT

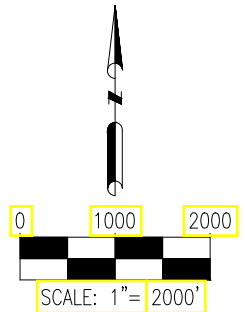


TROUDT 41C-23-M WELL TO BE LOCATED 760' FNL AND 1684' FWL, SEC 27, T6N, R66W
