## SOURCE REMOVAL SUMMARY

Between April 11 and 17, 2017, supplemental excavation and monitoring well installation activities were conducted in accordance with the approved Form 27. Approximately 320 cubic yards of soil was removed from the Site and transported to the North Weld County Landfill in Ault, CO for disposal. Three groundwater monitoring wells (BH09, BH10, & BH11) were installed upgradient and groundwater monitoring activities were conducted on May 30, 2017. Please refer to the attached Second Quarter 2017 Groundwater Monitoring Summary Report for the Site which details excavation and groundwater monitoring well installation and sampling activities.
