Comment: This location does not meet reclamation requirements. The well location appears to meet Rule 1004 standards but the tank battery location does not meet Rule 1004 standards. Disturbance areas from the tank battery are not reflective of reference areas. Location mainly consists of weedy, annual vegetation and appears gravel material may have been left at location. Refer to the attached inspection photos for more detail.

Corrective Action:	Perform reclamation in accordance to Rule 1004. Establish vegetation with, non-invasive, uniform plant cover of at least eighty (80) percent of reference area levels. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
