Comment:

The well and battery location do not meet reclamation requirements. The well location has not been contoured to match the surrounding landscape. Rill erosion evident along the eastern cut slope. The battery location had a List B Colorado noxious weed, Diffuse knapweed (*Centaurea diffusa*), throughout the location which is not reflective of reference area vegetative conditions, in addition to stormwater erosion issues. It does not appear the access road between the well and battery location was properly contoured as well. Refer to the attached inspection photos for more detail. COGCC staff does not have photos of the battery location because it was not known until after the inspection that the battery location was Petroshare's.

Corrective Action:

Perform reclamation in accordance to COGCC 1004 reclamation rules and requirements. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Final reclamation activities shall be complete no later than March 15, 2018.
