Perform reclamation in accordance to COGCC 1000 series rules and requirements. Recontour/regrade the cut slope, and northeast ends of well pad, as well as areas of the access road where stormwater degradation is occurring, ruts remain evident and vegetation has not established uniform cover. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.

Operator Comment: Noble has recontoured, reseeded, and fenced off the areas marked out by COGCC in agreement with the landowner, and installed stormwater controls. This work was completed on November 10, 2017.
