Comment:

Inspector has indicated weed infestation in areas identified as within the east and south portions of the project area, but those areas are not within the project area. Those areas are outside of our Surface Use Agreement boundaries, outside of the project boundaries set forth in our Form 2A, and they are outside of the area of actual disturbance created by our project activities. They are therefore not within COGCC jurisdiction, and only the landowner has responsibility for (and access to) these areas.  
We will continue to control weeds within the project area, including all land disturbed by our activities.

It may be helpful to know that our surface location sits within a previous mined and abandoned gravel pit, and our access road is the road that served that gravel pit. The slopes that are south and east of our well location, which are generally the areas in dispute, were created by the gravel pit operations and not by us. We have attached plats from the relevant Surface Use Agreement, which are the identical plats in the relevant Form 2A, cross sections, and pictures from Form 2A that show the pre-existing topography to the south and east of the location that is outside the boundaries of the project area. Operator requests a factual finding that lands outside of our delineated surface area that have not been disturbed or damaged by our activities, are not subject to COGCC reclamation rules.
