INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On September 8, 2017, historical impacts were discovered during P&A activities at the Guy Jones GU #1 production facility. Approximately 1,180 cubic yards of impacted material were removed and transported to the Kerr-McGee Land Treatment Facility in Weld County, Colorado. Groundwater was not encountered in the excavation. The COGCC has assigned Spill/Release Point ID 452201 to this release. A partially-buried produced water vessel was removed during excavation activities.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Soil samples were collected from the sidewalls and base of the excavation area at depths ranging from 6 to 14 feet below ground surface (bgs). The soil samples were submitted to Origins Laboratory for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), total petroleum hydrocarbon (TPH) - gasoline range organics (GRO) by USEPA Method 8260C, TPH diesel and oil range organics (DRO and ORO) by USEPA Method 8015, electrical conductivity (EC), and pH. Laboratory analytical results indicated that constituent concentrations in the soil samples collected from the final extent of the excavation area were below the applicable COGCC Table 910-1 soil standards, with the exception of the pH concentrations in samples S06, E06, and B07, which were collected below the root zone. Soil sample analytical data is presented in Table 1, and soil sample locations are illustrated on Figure 1. The laboratory analytical reports are included as Attachment A.

On September 8, 2017, excavation activities were initiated and approximately 1,180 cubic yards of impacted material were removed and transported to the Kerr-McGee Land Treatment Facility in Weld County, Colorado. A partially-buried produced water vessel was removed during excavation activities.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Laboratory data indicate that impacted soils in the excavation area have been remediated to below COGCC Table 910-1 standards, with the exception of the pH concentrations in samples S06, E06, and B07, which were collected below the root zone. Based on the analytical data presented herein, remediation is complete at this site. Upon COGCC approval of the Initial Form 27, Kerr-McGee will submit a Supplemental Form 27 request for a No Further Action (NFA) determination for this release.
