<p>Inspection #682502488 documented that the Tank battery location has not had gravel removed, compaction alleviation performed or returned to crop land. Crop growth at disturbed areas adjacent to the tank battery, areas along access road and the well location is stunted and not reflective of the reference areas, and that this was likely due to compaction concerns. Inspection required operator to perform reclamation in accordance to COGCC 1000 series reclamation rules and requirements.</p> <p>Unable to find evidence that additional reclamation has been conducted per the corrective action; former tank battery location remains unreclaimed.
