For the most recent field inspection report of this facility, please refer to document #680602070. COGCC Regional Engineer Mark Weems and SW Field Inspector Cal St. John were on site during this field inspection. An A+ Well Services rig crew was on site to continue PA operations. During this site visit the well head was cut off in preparation of welding on the PA well identification plate. The surface casing was not cemented to surface as the well file indicated. Plans to cement the surface casing were made. A trench was dug on the downhill side of the stockpiled soil removed from around the wellhead, until the soil can be disposed of.</p>	hughesj	11/27/2017
