Comment: More of Location Fence is down & in disrepair than in Previous Inspection; it has become Debris. Noxious weeds are on Site. Bare areas noted in previous Inspections are not filling in with desirable vegetation. As noted in 2016, down fence has allowed Livestock access to site resulting in severe grazing of vegetation, compaction of bare areas & conditions favorable to Weed growth. It is recommended to repair fencing & exclude Livestock from Location until vegetation has established & site has passed Final Reclamation.
