Unable to find evidence that additional reclamation activities have been conducted per the corrective actions. Original corrective action and date remains applicable.

Date **11/15/2017**

Perform reclamation; Collaborate with the surface owner to determine a seed mixture to be used to stabilize the location with total perennial, non-invasive uniform plant cover. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. To allow for a fall seeding, revegetation activities shall be complete no later than 11/15/2017.
