Andrew &amp; Jennifer,

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

1) In the Facilities section Nickel Road has indicated there will be 48 condensate tanks and 12 water tanks. However, the Facility Layout Drawing depicts only 30 condensate tanks and six water tanks. Furthermore, the Facilities section indicates there will be four Vapor Recovery Units, eight VOC combustors, one LACT Unit, and eight Vapor Recovery Towers, yet the Facility Layout Drawing does not depict any of these production facilities. So I am uncertain as to the actual planned count of production facilities on this proposed Oil & Gas Location. Please confirm the count of production facilities and revise the Facility Layout Drawing so that it agrees with what is listed in the Facilities section.

2) Please provide the following additional information concerning the planned use of MLVTs:

- \* The anticipated timeframe they will be onsite in days or weeks
- \* The manufacturer or vendor of the MLVTs

Doug, thank you for providing the comments on the Drake pad Form 2A. Please see below for responses:

1) My apologies for the discrepancy in facility counts. I would like to update the Facilities tab to match the facility layout dwg with 30 condensate tanks and 6 water tanks. The remainder of the equipment in question will be located in the area designated as "Separator & Combustor Area" - we have accounted for all appropriate setbacks and spacing needs for these pieces of equipment. I can update the dwg label to indicate this if you would like or I can prepare a comment to add to the operator comments section - please let me know how you would like to proceed.

2) MLVT manufacturer / vendor: Rain for Rent, Inc. or Resource West, Inc.

Anticipated time frame on location is up to 12 months as discussed with surface owner and in support of multiple completion occupations.

Thank you for the clarification on the Facilities count. The Facility Layout Drawing requires that all equipment listed in the Facilities section be depicted on the Facility Layout Drawing. Indicating on the drawing that the remainder of the equipment will be located in the area designated as "Separator & Combustor Area" is not sufficient. That being said, a Facility Layout Drawing is only required when the location is within a Buffer Zone. As this proposed Drake Pad is not within a Buffer Zone, the Facility Layout Drawing can be removed from this Form 2A. Otherwise, it needs to be revised to depict all of the pieces of production facilities listed in the Facilities section. Please let me know how Nickel Road wishes to proceed.
