	<p>Gates were down at Location & it was evident that cattle had been grazing the Site. Noxious Weeds are established over the Location; hundreds of B List, Houndstongue & a few Thistle plants were noted as well as C List, Mullein. Desirable Vegetation is well established and would likely pass the 80% of Reference area requirement. The vegetation tab is being kept "IN PROCESS" until Follow Up Inspection to document Resolution of the CA for Noxious Weed control. CA can not be given to Repair Fence (unless it has become Debris; then CA to Repair or Remove); however it is recommended to repair fencing & exclude Livestock from Location until site has passed Final Reclamation. Refer to Photos attached.</p>	
Corrective Action:	<p>Control Noxious Weeds; commencing application of controls in early growing season of 2018, at least before seed head maturity. Continue to Monitor site & schedule Weed control applications as needed.</p>	Date 06/01/2018
