Comment: Inspection #682502594 required operator to remove concrete pump base and to reclaim location and access road. Pump base has been removed, however access road remains unreclaimed, and unable to find evidence that additional reclamation/revegetation activities have been conducted on the location per the corrective action. Original corrective action and corrective action date remains applicable.

Corrective Action:	Perform reclamation in accordance to COGCC 1000 series reclamation requirements including, but not limited to, compaction alleviation, recontouring/ re-grading, and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels on the location and access road. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.	Date	11/15/2017
