#### OPERATOR COMMENT AND SUBMITTAL

Comment: Field would like to comment regarding some verbiage that was used in report. "Horizontal heater treater" has "no secondary containment" this information is incorrect. This same mistake was noted on another inspection at the BC 5-14. Unable to comment on that insp due to no CA. The piece of equipment that is being referred to (and has photo of) is a propane heater. It is not a propane process vessel and secondary containment would be unsafe due to propane vapors being heavier than air. Any small propane leak would vaporize and collect in containment resulting in ignition from the burner. Comment is incorrect and should be removed.
