Comment: Inspection conducted to assess flowline release between wellhead and separator. Weather is 17F and windy. Area around leak has been excavated. Flowline is covered with tarps to prevent freezing. No visible staining or odors from excavation. Landfarm has been constructed at SE of pad. Landfarm is ~80 x 40x1.5 ft. Soil is spread on poly-lined surface with dirt berms. Material appear to be a mix of soil and friable bedrock.

Corrective Action: Per F-19: Assess nature and extent of contamination. Submit a Supplemental F-19 within 10 days. Remediate to Table 910-1 standards and provide documentation. An F-27 for extended remediation under landfarming is required. Surface owner permission is required for any onsite remediation. Financial assurance in a dollar amount equal to the cost of offsite disposal may be required by COGCC for onsite remediation.
