Approximately 1,190 cubic yards of impacted soil was excavated. Confirmation soil samples indicated that the impacted soil above the groundwater saturated zone was removed via excavation activities. A mixture of activated carbon and gypsum was placed at the water table in the excavation to aid in groundwater remediation.
