Operator Comment: grade of the western side the location was raised to funnel stormwater to newly installed diversion ditches along the northern and southern edges of the well pad. Newly constructed diversion ditches convey stormwater runoff to a series of rock check dams and rock armoring before discharging into county road bar ditch. All new disturbance within the stormwater diversion ditches have been seeded and mulched. Corrective Action has been successfully completed and location is ready for re-inspection.
