#### COMMENTS:

The well was originally shut-in for a Bradenhead Squeeze Prep, but it was not completed. A CIBP was set at 7410' and cement was set from 815'- 1560' and remains in the wellbore. A pressure test was conducted on 4/20/2017 at 500PSI - held for 15 minutes. The well will continue to be temporarily abandoned until the well is plugged and abandoned. T&A status provided via a down-hole plug and surface isolation provided by a closed master valve.
