	<p>Previous inspections required the well pad location, and portions of the access road to be recontoured/reggraded and revegetated. Reclamation at the areas appear to have been conducted. Previous inspections also required that additional reclamation be conducted within areas of the fenced remediation area that are bare/exposed soil and/or predominantly undesirable weedy plant species. These areas were noted as requiring work during site visits with the operator. Unable to find evidence that additional reclamation activities have been conducted within these areas. See photos 9-10 in the attached photo document. Corrective action will remain applicable until completed.</p>	
Corrective Action:	<p>Perform reclamation in accordance to COGCC 1000 series rules and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.</p>	Date 08/31/2017
