	<p>Inspection Doc. #682501867 and #675103796 documented and required operator to repair or remove straw wattle BMPs in disrepair on the location, remove a cattle guard identified as belonging to the operator from the access road, and to perform additional reclamation on unvegetated areas of the location. Wattle BMPs remain on location in disrepair and are considered debris, cattle guard remains on access road and large unvegetated areas on the southern end of the location remains predominantly bare and exposed soil with no evidence that additional reclamation has been conducted per the corrective action. Original corrective action and corrective action date remains in place.</p>	
Corrective Action:	<p>Repair or remove and properly dispose straw wattle BMPs currently in disrepair on location. Remove cattle guard. Perform additional reclamation on unvegetated areas of location and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the landowner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 5/31/2017.</p>	Date 05/31/2017
