We have not received any objections to such well location or proposed spacing unit, therefore Verdad hereby requests the Director to approve the proposed wells.

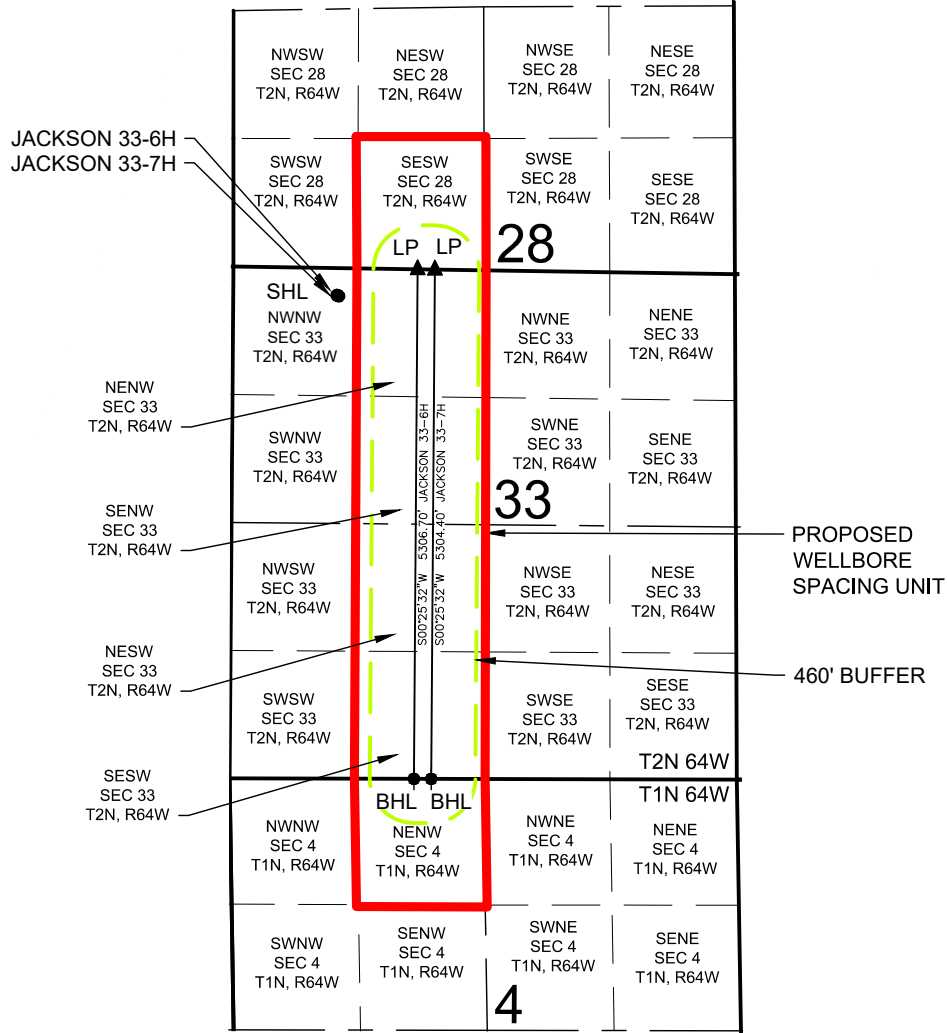

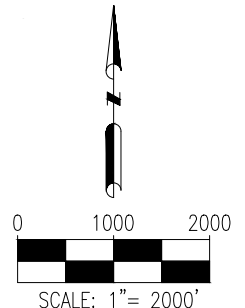
JACKSON 33-6H WELL TO BE LOCATED 283' FNL AND 1081' FWL, SEC 33, T2N, R64W
