Heavy infestation of Noxious Weed, Scotch Thistle is established on Location & Access Road to the degree of restricting vehicle access & movement.

Corrective Action There are three CAs in this Section. CA#1) Shrink Location for Interim Reclamation as per COGCC 1003 Series Rules. Conduct reclamation in areas no longer needed for Use or production, including weedy sparsely vegetated Fill Slopes in revegetation plans, installing appropriate BMPs to Stabilize Areas until Vegetation establishes. Reclamation Activities should be complete by 11/30/172017. CA#2) Mow weeds (Scotch Thistle) on Access Road, enabling accessibility of Site by 11/1/17. CA#3) Weed Control, Monitoring program and schedule (for Location & Access Rd) need to be developed and in place by 11/15/17.
