	<p>This location does not meet reclamation requirements. Operator has failed to reclaim the access road and has failed to reclaim about 1/3 of the well location and a rock stockpile remains at location. Appears the Operator has recently performed reclamation activities along the southern, western and northern well location. Fence remains around the location. COGCC staff would recommend leaving the fence while vegetation establishes at location to keep cattle and other critters out during the reclamation process. Refer to the attached inspection photos for more detail.</p>	
Corrective Action:	<p>Perform reclamation in accordance to COGCC 1004 reclamation rules and requirements. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. The Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards. Final reclamation activities shall be complete no later than April 30, 2018.</p>	Date 04/30/2018
