This is an environmental inspection to document status of spill of produced water. Operator reported "It is estimated at this time that 3bbls to 5bbls of produced water were spilled with no State Waters involved. The spill ran down the main road a short distance, through cattle guard were it ended in a meadow just off the road. Plans for repairs and investigation are to follow."

Inspection of spill confirms operator report. It does not appear that a large volume of fluid was spilled. Spill was primarily confined to road ditch and cattle guard.
