#### COMMENTS:

On 1/28/2018 the Nabors B16 rig experienced top drive problems that required the open hole resistivity tool to be pulled out of the hole. At that time the tool had logged the first 3000' of the well. The tool was run back into the hole and at ~5000' there was an issue with the LWD tool. At that time it was discovered that open hole resistivity tool had also failed. Burlington Resources conferred with COGCC staff and the decision was made to proceed ahead with open hole resistivity logging from 5000' onward to the KOP. Resulting in a 2000' gap in the open hole resistivity log.
