3. TIH with CIBP. Set BP at 7149'. Top with 2 sxs 15.8#/gal CI G cement.
4. TIH with CIBP. Set BP at 6836'. Top with 2 sxs 15.8#/gal CI G cement.
5. TIH with casing cutter. Cut 4 1/2" casing at 3000'. Pull cut casing.
6. TIH with tubing to 3125'. RU cementing company. Mix and pump 60 sxs 15.8#/gal CI G cement w/ 2% CaCl down tubing.
7. Pick up tubing to 2605'. Mix and pump 185 sxs 15.8#/gal CI G cement.
8. Pick up tubing to 700'. Mix and pump 345 sxs 15.8#/gal CI G cement. Cement should circulate to surface.
9. Cut surface casing 6' below ground level and weld on cap.
